Public participation:

The following matters were raised:-

Update on installation of a grit bin just over the border in Martin;

A broken sign on Browns Lane is to be reported on Hantsweb (*reported post-meeting ref: 21443814*);

the bad state of the wooden 'To the Church' sign on the junction of Court Hill and Church Lane was discussed and agreed for the Churchwarden to raise at the next PCC meeting (as it is not a HCC sign);

issues with heavy traffic during the Jubilee Camping event the previous weekend.

1. Apologies and declaration of quorum

19/07/76

Apologies were received from Ros Jones, and assumed from Cllr Doherty.

19/07/78

The issues with the recent surface dressing to the roads in Damerham was discussed, and CCLr Heron explained the process of the repair, advising the bitumen is actually to fill cracks on the road and the grit enables driving on it.

Potholes are not usually repaired before surface dressing. CCLr Heron requested for examples of the worst 2 cases to be photographed and sent to him so he is able to follow this up. **Cllrs Crane and Stephens agreed to do this.**

The chairman brought forward the following agenda item:

7.i. Jubilee Camping, Browns Lane – update on site

19/07/79

Attending residents raised concerns regarding the creation of the access track to Cornpitts Lane – does it require planning permission? The owners have confirmed that it is not going to be an entrance but has been created to minimise disturbance to other residents. CCLr Heron updated attendees on the current situation: Natural England's opinion is there is likely to be an adverse effect on the habitat, which mean the 28-day rule of camping activities does not apply. The owners have been advised that planning permission will be required, which can then be carefully conditioned to regulate the activities on the site. It would not be expedient for an enforcement stop notice to be issued, so 12 September event would be able to go ahead.

It was noted by several who had attended that the event the previous weekend was a well organised family event. The use of a one-way system for traffic for 12 September was discussed, and it was suggested for a special meeting to be arranged to discuss this with the owners.

19/07/84

- i. Update on Parish Projects.

Footpath leaflets: the leaflets have printed.

Village Recycling Centre: Cllr Simmons had emailed all councillors with her progress on this project. The pupils at western Downland School are very enthusiastic and happy to house the recycling centre and monitor/redistribute the donations. The recycling centre will be sited so it is available to all villagers.

Cllr Simmons requested funding of around £200 to enable equipment to be purchased and sited at the school ready for September. **Cllr Major proposed to fund £250. Seconded, all in favour (7).**

Full details of what can be recycled will be in the September Parish Pump and on the website.

Cllr Heron suggested recycling aluminium food trays would be welcomed.

Digitising the parish archives: not discussed as Cllr Doherty not present.

19/07/85

- ii. Update on Community Funded Initiative project. Cllr Crane advised a road closure will be required for the works at the exit from the footpath by Green Close. It is hoped it will be fast-tracked and happen in 2-3 weeks. The white lining is hoped to be completed by September.

The danger of speeding vehicles and cyclists was discussed on the bend at the bottom of Court Hill. Potential for signage was discussed, and planting to raise awareness of the village community.
