2. Declaration of interest by any councillor on any Agenda item:

3. To consider planning applications:

3.1 APPLICATION NUMBER: 23/10073

Address: Land at Manor Farm Cottage, Cornpits Lane, Damerham SP6 3HT

Proposal: Construction of a farm track: retrospective planning application.

Following discussion, a motion to recommend PAR3 was proposed, seconded and resolved (5).

The track is an improvement to a worn track that is already in situ.

The track enables the farmer to have better access to all areas in the property, thereby keeping tractors and mud off the road.

The new hedge that has been planted alongside is of benefit to the environment.
